This indemnity includes any claim or amount arising out of or recovered under the Workers' Compensation Law or arising out of the failure of such vendor to conform to any federal, state or local law, statute, ordinance, rule, regulation or court decree. It is the specific intention of the parties that the Indemnities shall, in all instances, except for Claims arising solely from the negligent or willful acts or omissions of the Indemnities, be indemnified by Vendor from and against any and all claims. It is agreed that Vendor will be responsible for primary loss investigation, defense and judgment costs where this indemnification is applicable. In consideration of the award of vending rights, the Vendor agrees to waive all rights of subrogation against the Indemnities, their officers, officials, agents and employees for losses arising from the vending performed by the Vendor at the Fabulous Phoenix 4<sup>th</sup> Festival on July 4, 2017.
