



Professional Certification Assistance

The Arizona Parks & Recreation Fellowship (APRF) and the Arizona Parks & Recreation Association (APRA) annually provides assistance to parks and recreation professionals for professional certifications in parks, recreation, natural resources, tourism or related field throughout Arizona.

Recipients are eligible to receive up to \$150 to offset expenses for attendance at a professional course or for certification test fees *that are not reimbursed by an employer, organization or other source*. The assistance will be paid upon documented completion of course or test on a first come basis until funds are exhausted.

Recipients will be recognized through APRF/APRA print and e-media as well as the Annual Arizona Parks and Recreation Association Conference and Trade Show.

Scholarships are evaluated on the following criteria:

- Completed applicant information form
- Purpose statement
- Letter of professional support from current supervisor
- Preference given for members that have served a minimum of 12 hours towards APRF/APRA programs/events within the last 12 months

General Guidelines:

- Demonstrate evidence of work in the parks and recreation profession
- Documented completion of course or test within one year from award of funding.

Application Procedures:

- All requested information must be submitted with the application

Certification Review Timeline

- Applications submitted January – May; review begins June 1
- Applications submitted June – August; review begins September 1
- Applications submitted September – December; review begins January 1

Applicants will be notified by the end of the month following each review date. There is limited funding available. Once the funding threshold has been met, no additional scholarships will be awarded for that year.
